

## 2019 Tax Season Newsletter



WHAT'S NEW for FEDERAL

- Tax Rates have dropped.
- Standard deductions approximately doubled.
- Personal exemption amounts removed.
- NOL carrybacks eliminated, NOLs must be carried forward.
- Casualty & theft loss deduction gone, unless in a federally declared disaster area.
- Job related moving expenses no longer deductible (active duty military PCS exception).
- State and local itemized tax deductions (income, excise, real estate, sales) capped at \$10,000.
- Mortgage and HE itemized deduction interest only deductible if used to buy, build or improve primary or second home. Must be secured by the property used for (loan interest secured by home 1 used to buy, build, or repair home 2 not deductible). HE and cash out loan interest used for other purposes also is not deductible.
- All miscellaneous itemized deductions subject to the 2% floor are gone. No more deductions for employee business expenses (including employee travel and meal expenses), investment expenses, hobby expenses, tax prep fees and legal fees that had been allowed as itemized personal income tax deductions in prior years.
- Child Tax Credit increased to \$2,000 per child with up to \$1,400 per child being refundable.
- Non-child dependent credit of \$500 per qualifying relative (older child, parent, etc.).

- Tax Preparers are now required to verify the qualification of a tax payer to claim Head of Household status, as well as taking the Earned Income Credit, Child Tax Credit and American Opportunity (education) credits.
- 529 Plan funds can now be used for qualified education expenses of public, private and religious K-12 grade schools.
- S179 depreciation limit is now \$1,000,000.
- Non-residential roofs, heating/AC equipment, & interior improvements are now are S179 eligible.
- 100% bonus depreciation now includes used qualifying property.
- Like kind exchange rules for real estate only. Can no longer defer gain from a like kind exchange of equipment, such as a tractor/trailer, or a piece of logging or construction equipment.
- Personal income tax deduction of 20% of qualified business income.

## WHAT'S NEW for MAINE

- Personal Exemptions limited to taxpayer and spouse, no exemption for other dependents.
- \$300 credit for dependents that qualified for the federal child or other dependent credit.
- Maine standard deduction equals federal.

TAX FRAUD HOTLINE. If you suspect or know of an individual or company that is not complying with the tax laws, you may report this activity by calling the IRS at 1-800-829-0433, or report on Form 3949-A (available at irs.gov). File Form 211 to receive a reward if applicable. Maine tax violations can be reported by email to mrs.taxtip@maine.gov, or by calling 207-624-9600. The caller can remain anonymous.

1065 & 1120-S due date.
1040, 1120 & 1041 due date.
Non-Profit 990N due date.
ME Annual Rpt. Due (Corp & LLC)
Extended 1065 & 1120-S due date.
Extended 1041 due date.
Extended 1040 & 1120 due date.

If you receive an extension, it is important to know that it is only an extension for time to file. You must estimate the amount of tax you will owe and pay it before the original due date to avoid late payment penalties. If you are on extension, and file your tax returns after the extended due date, late filing penalties and interest will be accessed back to the original date due, as if you did not have an extension.

To keep the IRS and state penalties for failure to file and late filing at bay, file your tax returns on time, even if you cannot pay right away.

LAST YEAR FOR THE ACA PENALTY. Tax year 2018 remains the same as 2016-17, \$695 per adult or \$2,085 per family or 2.5% of your household income in excess of your filing threshold, whichever is higher, paid through your 2018 tax year income tax return. The penalty is gone for 2019, which is filed in 2020.

MILITARY RETIRESS & SOCIAL SECURITY recipients will receive a 2.8% cost of living adjustment in 2019.
