2021 Tax Season Newsletter

WHAT WE ARE DOING. As an essential Maine business preparing tax returns and providing payroll services, we are open. We'll limit clients to just one at a time, so please call ahead for an appointment. If you do just stop by and someone is already here, you can leave your paperwork, and we will call you to interview over the phone. PPP LOANS. If you received a PPP loan for your business, many banks have started taking forgiveness applications. You may want to delay requesting forgiveness pending more favorable rules and applications. As it stands now, if your loan is forgiven, the forgiven amount is not taxable by the IRS as forgiven debt. Since it is tax free income upon forgiveness, per the current federal rules, no expenses paid with this money are allowed to be deducted. You cannot take a business deduction for expenses paid with federally tax-free income. BUT Maine doesn't go along with this. You must add back to Maine the tax-free federal income resulting from a forgiven PPP loan, but you can then take the expenses that had been disallowed by the IRS federally. If by 12/31 it is not forgiven, it is still a loan. Loans are never income. You do not add it to income. Because it is not yet income, either taxable or tax free, but is still a loan, you DO take the expenses paid by the loan in 2020. This is not an issue to be resolved until the date of forgiveness. At that time the loan goes away, is replaced by tax free income, and an adjustment for expenses paid in 2020 with tax free income must be made. If you have a PPP loan, forgiven or not, you may want to extend your due date to see if any more changes are made and avoid having to amend.

DID YOU OWE THE IRS LAST YEAR? Update your W-4 with your employer so you won't owe next year. The IRS advises taxpayers to use the Tax Withholding Estimator tool to check their withholding and help with completing the W-4. Here's the link. <u>irs.gov/individuals/tax-withholdingestimator</u>. If we do your taxes, you may also see us outside of tax prep season for a withholding review.

WHAT IF I GET AN EXTENSION? It is important to know that it is only an extension for time to file. You must estimate the amount of tax you will owe and pay it before the original due date to avoid late payment penalties. If you are on extension, and file your tax returns after the extended due date, late filing penalties and interest can be accessed back to the original date due, as if you did not have an extension.

To keep the penalties for failure to file and late filing at bay, file your tax returns (forms) on time, even if you cannot pay with the return, and plan to pay later.

MILITARY RETIREES & SOCIAL SECURITY recipients will receive a 1.3% cost of living adjustment in 2021. This is down from last year's 1.6% increase.

RETURNS WE PREPARE include 1040 personal income tax returns, sole proprietor returns, landlord and rental income returns, farm returns, partnership returns, corporate income tax returns, and also amended returns, prior year returns, and extensions of time to file.

ECONOMIC IMPACT PAYMENT also known as the STIMULUS PAYMENT. What is it? It is an advance payment of a 2020 income tax credit. Is it taxable? No, it is not taxable. Since it was an advance payment, you may have additional credit due to you if the advance was smaller than it should have been. Keep the notice you received regarding this payment and give it to us with your tax paperwork so we can reconcile your credit when we prepare your taxes. Providing an incorrect amount could cause a data mismatch at the IRS and delay your return. If you were given too little, you will get the balance as an adjustment to your 2020 income tax, and if you were paid too much, you will not have to pay it back. It will not be an adjustment to your 2020 taxes if you were overpaid the credit in advance.

WE PROVIDE PAYROLL SERVICES. You give us your employee hours worked each period and we'll prepare your signed or unsigned payroll checks, employee direct deposits, or detailed pay-stubs for you to attach your own check to. Q. What's the difference between death and taxes? A. Congress doesn't meet every year to make death worse. Believe it or not, TAX DAY is once again April 15th unless it is changed due to the pandemic again. It is not affected by Patriot's Day or Emancipation Day in 2021.

BUSINESS AUTO DEDUCTION is always a hot topic. To deduct either the actual costs or take standard mileage the business owner must have a written record to substantiate the deduction. A perfect record will show the date of the trip, business purpose, start and stop odometer readings, total miles of the trip, and the Jan 1st and Dec 31st odometer readings. This is all that's needed for the standard mileage deduction. To take actual expenses all the above is required as well as all receipts for all fuel, repairs, taxes and registrations, insurance as well as date and purchase price of the vehicle. The business miles divided into the total miles will then establish the percentage of actual costs that are deductible.

TAX FRAUD REPORTING. If you suspect or know of an individual or company that is not complying with the tax laws, you may report this activity by completing Form 3949-A (available at irs.gov). File Form 211 to receive a reward if applicable. Maine tax violations can be reported at <u>maine.gov/revenue/taxes/compliance/tax-violation-hotline</u>, or by email to <u>mrs.taxtip@maine.gov</u>, or by calling 207-624-9600. You can remain anonymous.

DIRECT DEPOSIT AND DIRECT DEBIT. Early on in the pandemic IRS employees were sent home. As processes and procedures were put together, the mail to the IRS was warehoused. This resulted in many checks to the IRS for taxes due being uncashed. You can use direct deposit for refunds and direct debit for amounts due to avoid delayed or lost mail. If you use direct debit you can choose the date of payment up to the due date, normally April 15th for a 1040 amount due.
